**Preamble:**

In the Government of India letter dated:30-04-2014 read at (1)above, Government of India has released its balance amount of Rs 12.17382 Crores as 2<sup>nd</sup> installment of 2013-14 for projects sanctioned during the year 2009-10,2010-11, 2011-12 and 2012-13 under the Centrally Sponsored Scheme 'Intergrated Watershed Management Programme' (IWMP) for implementation in Karnataka.

The Government of Karnataka, Finance Department (Fiscal Reforms Cell) in the letter read at ( 2) above, has confirmed the receipt of GOI share of Rs 1217.38 crores under IWMP Scheme from Ministry of Rural Development, Department of Rural Developmnet & Panchayat Raj, Government Of India through its Credit Confirmation Slip.

In this background, The Chief Executive Officer, SLNA & Commissioner, Watershed Development Department has requested the Government to release GOI share amount of Rs.12.17382 Crore as well as its corresponding State share amount of Rs, 1.3526467 Crore, totalling to Rs, 13.5264667 crore under 2014-15 IWMP Head of Account :2402-00-102-0-30 (Plan). Further, he has also requested to permit to draw above said funds through Grant- in -aid bills from State treasury under IWMP.

Keeping all these in view, the government has decided to release GOI balance amount of 2<sup>nd</sup> installment of 2013-14 for projects sanctioned during the year 2009-10,2010-11, 2011-12 and 2012-13 under the Centrally Sponsored Scheme 'Intergrated Watershed Management Programme' (IWMP) of GOI share along with its corresponding State share (10%) to Watershed Development Department for implementation of IWMP scheme in the State.
