In the Government Order read at (2) above, Government has released total amount of Rs.13.5264667 crore, which include Government of India (Central share) balance amount of Rs. 12.17382 Crore as 2<sup>nd</sup> installment of 2013-14 for projects sanctioned during the year 2009-10, 2010-11, 2011-12 and 2012-13 by Government of India under the Centrally Sponsored Scheme 'Integrated Watershed Management Programme' (IWMP) along with its corresponding State share (10%) of Rs.1.3526467 Crore, for the implementation of IWMP in the State during 2014-15.

In the Government of India letter read at (3)above, GOI has released first installment of central share of Rs.74.54 Crore in 2014-15 for projects sanctioned from 2009-10 to 2013-14 under the Centrally Sponsored Scheme Integrated Watershed Management Programme' (IWMP) for implementation in Karnataka State during 2014-15.

In this background, The Chief Executive Officer, SLNA & Commissioner, Watershed Development Department has requested the Government to release GOI Central share amount of Rs.74.54 Crore as well as its corresponding State share amount of Rs.8.282222 Crore, totalling to Rs, 82.822222 Crore under Integrated Watershed Management Programme' Head of Account: 2402-00-102-0-30 (Plan) during 2014-15. Further, he has also requested to permit to draw above said funds through Grant-in—aid bills (GIA) from State treasury under IWMP.

Keeping all these in view, Government has decided to release GOI central share of 1<sup>st</sup> installment of 2014-15 for projects sanctioned from 2009-10 to 2013-14 under the Centrally Sponsored Scheme 'Integrated Watershed Management Programme' (IWMP) along with its corresponding State share (10%) to Watershed Development Department for implementation of IWMP scheme in the State.
