Sub: Invoking prevented /Failed sowing and prevented planting/ germination due to prolonged dry spell and drought under KRS-PMFBY in Hassan district during Kharif 2019-reg

Preamble

In the Operational guidelines of Prime minister Fasal Bhima Yojana read at (1) above, in Para XIII, it has been mentioned that "It is proposed to provide Insurance cover to farmers in case of widespread incidence of eligible risks (prevented/failed sowing and prevented planting/germination claims) affecting crops in more than 75% of area sown in a notified unit at early stage leading to total loss of crop or the farmers are not in a position to either sow or transplant the crop".

In the Notification read at (2) above, implementation of Karnataka Raitha suraksha- PMFBY in all the 30 districts of the state during Kharif-2019 has been notified.

The Commissioner for Agriculture, Bengaluru in his letter dated 26/06/2019 read at (3) above, has submitted a proposal to Invoke prevented/failed sowing and prevented planting/germination due to prolonged dry spell and drought in Hassan district under KRS-PMFBY during Kharif-2019. With respect to the Government Notification: AGD 35 AAE 2019, Dt:22.04.2019 the enrollment cutoff date for Green gram (RF) crop in Hassan district is 15.06.2019 and the prevented sowing invoking cutoff date is 29.06.2019. As per the PMFBY guidelines (revised) the last date for prevented sowing invoking is 15 days after the enrollment cutoff date.

The details of Gram panchayath level total area sown and area affected due to prolonged dry spell of the district are also submitted in the proposal.

Further Commissioner for Agriculture has also requested to direct the Implementing Insurance Companies to take immediate steps for timely loss assessment and claim settlement under the provision. The District level monitoring committee to co-ordinate with concerned Insurance Company in this regard.

The proposal of the Department has been examined, hence the Order.

Government Order No. AGD 37 AAE 2019 , Bengaluru Dated: 29/06/2019.

For reasons mentioned in the preamble, the provision for prevented/failed sowing and prevented planting/germination claims is hereby Invoked for the Gram Panchayaths of Arasikere taluk, Hassan district as annexed, for the Green Gram (RF) crop during Kharif 2019.

As per the Operational guidelines;

"The Implementing Insurance Company should take immediate steps for timely claim settlement under the provision, The District level monitoring committee shall co-ordinate with the concerned Insurance company in this regard."
