## **Preamble**

As per paragraph 21.2.1 of the Revised Operational Guidelines of Pradhan Manthri Fasal Bhima Yojana read at (1) above, provision has made that "Insurance cover will be provided to the farmers to provide immediate relief in case of adverse seasonal conditions during the crop season viz. floods, prolonged dry spells, severe drought etc., wherein expected yield during the season is likely to be less than 50% of normal yield".

As per notification read at (2) above, the Revised Operational Guidelines of Pradhan Manthri Fasal Bhima Yojana have been notified for the implementation in all insurance units of all the 30 districts of the State in Kharif-2019.

In the consent Letter read at(3) above Agriculture Insurance Company has given its consent to Invoking Mid-Season Adversity in eligible IU's as per the Scheme guidelines.

Subsequent to the meeting of the State level Grievance Committee held on 27.09.2019, the Commissioner for Agriculture, Bengaluru in the single file read at (4) above, has submitted a proposal to invoke mid-season adversity for the crops affected due to floods in Haveri and Vijayapura Districts under KRS-PMFBY during Kharif-2019. This has been on the basis of reports received from District Level Committee of these districts and the decision of the State level Grievance Committee

The details of total area sown and area affected due to floods in Haveri and Vijayapura Districts are also submitted in the proposal.

Further, the Commissioner for Agriculture has also requested to direct the Implementing Insurance Companies to take immediate steps for timely settlement of Mid-Season Adversity claims as per the direction of District Level Monitoring Committee and State level Grievance Committee.

The proposal of the Department has been examined, hence the Order.

## Government Order No. AGD 55 AMS 2019, Bengaluru

Dated:14/10/2019.

For reasons mentioned in the preamble, the provision for on account payment of claims due to Mid-Season Adversity is hereby invoked for the Insurance Units in Haveri and Vijayapura Districts during Kharif 2019 recommended by the District Level Committee.

The Commissioner for Agriculture is authorized to issue the Insurance Unit wise yield loss assessment and initiate the Mid-season adversity claims in the Samrakshanae portal.

As per the Operational guidelines, the Implementing Insurance Company should take immediate steps for timely claim settlement under the provision and the District Level Monitoring Committee shall co-ordinate with the concerned Insurance companies in this regard.
