Subject : Release of Karnataka State Government's share of 20% towards payment of arrears consequent to implementation of 2006 revised UGC/ICAR pay scales to Agricultural Universities.

PREAMBLE :-

In Government order read at (1) above, permission was granted to adopt UGC scales to the teaching and equivalent personnel of the UASs in Karnataka. Consequent to the release/sanction of 40% out of 80% share by the ICAR, the State Government released proportionate amount of 20% share, viz., Rs. 937.951 lakhs to UAS, Bengaluru, Rs. 751.460 lakhs to UAS, Dharwad and Rs. 149.370 lakhs to UAS, Raichur vide Government order read at (2) above. Now the ICAR in their letter read at (3) above furnished concurrence and released Rs. 25,01,19,400/- on 14-03-2011 to the UAS, Bangalore, Rs. 9,46,52,400/- on 28/02/2011 and Rs. 82,14,000/- on 30-03-2011 to the UAS, Dharwad and Rs. 3,98,34,082/- on 04-03-2011 to the UAS, Raichur towards the balance share of 40% out of 80%. Hence, the UASs Bengaluru, Dharwad and Raichur vide their letters read at (4), (5) and (6) above requested the State Government to release the balance 10% amount of State's share of 20% towards payment of arrears consequent to the implementation of 2006 revised UGC/ICAR pay scales. Accordingly a sum of Rs. 3.20 crores to Bengaluru, Rs. 1.25 crores to Dharwad and Rs. 0.55 crores to Raichur Agricultural Universities was released vide G.O. read at Ref (7) above. The Government further examined the proposal of releasing the balance amount and hence the following order.

ORDER

The Government of Karnataka for the reasons stated in the preamble hereby accords permission to release the following amount for payment of arrears for fixation of ICAR UGC pay scales to the teachers and equivalent official of the Agricultural Universities for the period from 01-01-2006 to 31-03-2010. Shown against each UASs to be met out of grants under the Head of Account 2415-80-277-2-13 (Non Plan) :-
